#### **STALLS**

The fee for a stall *with doors*, tack or horse, for the duration of the show is \$85.00. No jump-outs are allowed. **To reserve stalls, call Sandy Backer at 573-220-3430**. Stall reservations must be received no later than May 24, 2014. No first bedding will be provided. **To order bedding, call the Events Center at 573-474-9435.** 

#### **ENTRY FEES**

Exhibitors are responsible for their own errors and those of their agents in making out entry blanks. The address of the recorded owner or lessee must be given even if the horse is entered by an agent. Entries must be properly signed by the exhibitor or his or her authorized agent and must be accompanied by a check that covers all fees. No horse will be entered until a properly completed entry form is received by the show management and all fees are paid. Management reserves the right to change, combine, split or cancel classes and to make any changes it deems necessary.

Entry fees for all qualifying classes are \$15.00 Entry fees for championship or stake classes are \$25.00. The Trainer's Equitation Challenge will feature an added \$200.00 purse, to be awarded the winning exhibitor. All **entry fees** collected in the class will be donated to the recognized charity of winner's choice. Entry fees in the Trainer's Equitation Challenge are \$25.00.

Post entries will be accepted but early entries are encouraged. All horse/ rider combinations will be assessed a \$15.00 office fee.

All accounts leaving a signed check in the office hereby agree that management can fill in the amount that management reasonably believes is the amount due and owing and no liability to the management, Calvary Episcopal Charity Horse Show or Calvary Episcopal Church will accrue for the check having been filled out in that amount.

No refunds will be made if a horse or pony is withdrawn by an exhibitor or agent for any reason other than the horse or pony's death or illness. A certificate from a veterinarian must be presented certifying that the horse or pony in question has been injured or is otherwise not in fit condition to be shown. Only class entry fees may be refunded. Stall fees and office fees will not be refunded.

Entry fees for UPHA Classics are as follows: Entry fee is \$100.00. There is a \$50.00 eligibility fee if paid by April 1st (\$100.00 after April 1st); \$50.00 Nominating Fee (due to horse show by May 15); \$50.00 starting fee (due 24 hours before the class). If the UPHA Classics are not sponsored, they will be held as open 3 year old classes.

### **RULES AND REGULATIONS**

EVERY CLASS OFFERED HEREIN, WHICH IS COVERED BY THE RULES AND SPECIFICATIONS OF THE CURRENT MHSA RULE BOOK, WILL BE CONDUCTED AND JUDGED IN ACCORDANCE WITH THOSE RULES AND THE RULES OF THE PONY EXPRESS CIRCUIT. ANY CONFLICT BETWEEN THE RULES OF THOSE TWO ORGANIZATIONS WILL BE RESOLVED IN FAVOR OF THE MHSA RULES, IF ONE APPLIES. EXHIBITORS ARE EXPECTED TO KNOW THE RULES GOVERNING THEIR ENTRIES AND, BY ENTERING THIS COMPETITION, ARE DEEMED BOUND BY THOSE RULES **AND REGULATIONS.** Every person who participates in the show is responsible for knowledge of and is subject to the rules. All exhibitors in the Calvary Episcopal Charity Horse Show will be under the control and direction of the Horse Show Management and said Management will in no case be responsible for loss, damage or injury to horses exhibited, attendants or exhibitors. By participating in this equestrian activity, all participants agree that Calvary Episcopal Charity Horse Show, its officers and agents, Calvary Episcopal Church, the Central Missouri Events Center, Tag Events LLC, and the County of Boone, will not be held responsible for any injury, loss or death resulting from participation in this equine event, whether due to negligence or any purposeful act.

Calvary Episcopal Charity Horse Show is an MHSA and Pony Express Circuit sanctioned show. It will be run according to the rules of those organizations. If a conflict between the rules of those organizations exists, the rules of the MHSA will control.

Exhibitors are notified that any act of discourtesy by them, their riders, drivers, attendants or agents, to the judges or officials shall disqualify their entry and the owner shall forfeit his winnings, including all prizes won at this show.

The **original** of current (w/in 12 months) Coggins exams are required on all horses brought onto the grounds. Entries will not be accepted without proof of negative Coggins. Out of state entries will also be required to present a current (within 45 days) health certificate
