# QPEE MINI-EVENT RULES AND INFORMATION:

1. Hard hats are required at all times. Harness required for Juniors at all times, and when jumping for Adults.
2. All competitors must abide by MHSA, USEF, and USEA rules and regulations concerning eventing. See [www.qpee.org](http://www.qpee.org) for link to rules. **It is your responsibility to know the rules!**
3. Safety vests and medical information armbands are **required** for Divisions D and E. Safety vests are optional for Divisions A – C, but strongly recommended.
4. Competitors may **not** ride more than 2 horses.
5. All competitors must have the **original yellow copy** of their horse's negative Coggins dated within the last 12 months with them on show day or you cannot compete! State vets are checking this. Please, mail a **photocopy** with your entry!
6. Schooling will be permitted in designated areas before each phase of the event.
7. **No stabling on the grounds, stabling available at the National Equestrian Center, see [www.qpee.org](http://www.qpee.org) for contact info.**
8. Concessions will be available on the grounds.
9. Remember all Cross-Country is held in the main field, so allow extra time to walk your courses. Cross-Country maps with times and distance available at [www.qpee.org](http://www.qpee.org).
